To recap today's conversation:

TRILLIAN – Instant Messaging Must-Have App

Please download Trillian at <http://www.trillian.im/>

This is an instant messaging service that consolidates all instant messaging services into one application.

You can also get your Twitter feeds through this app and emails if you wish or use it stand alone.

I can walk you through the bells and whistles later, but for now...

a. Install the program and right click on the top bar where you see an empty space.

b. Choose Add Contact.

c. In the Username field, type "bitzee" (no quotes).

d. Choose ADD, put **Breitbart** as the reason and I'll accept the invitation.

VENTRILO – VoIP Communications Program

This is similar to Go-To-Meeting that allows the server ADMIN (you) to build an interactive gateway to BG news.

a. You want to go to the download page from this main URL: <http://www.ventrilo.com/>

b. Download the CLIENT application for your operating system and install it.

c. To make this less painful, I'll get you up and running by phone to exhibit how it works on our working server.

d. Our hosting is through DarkStarLLC: <http://www.darkstarllc.com/> and find it to be the most stable.

ANONYMOUS

a. A Hacker group solicited by Adbusters on IRC in early 2011 for use as a political weapon.

b. Co-opted by the left immediately for political use and frowned upon by the hacker factions therein.

c. Our goal was to:

1. Infiltrate Anonymous

2. Cause a rift between the left and the hackers by first proving to the hackers involved that they were being used

3. Provide them with enough information to ultimately attack the left

4. Uncover the mechanics of how the left would filter control of the organization's money to themselves

BOSTON POLICE & FBI – WHITE HAT GOALS

a. Work with Detective Blair of the Boston Police Department

- b. Feed Boston PD information on hacker activity that we are assured trickles up to the FBI
- c. Neal Rauhauser's name has already been dropped to them & being investigated
- d. As soon Anonymous arrests began to take place (already in progress), divert blame & tell Anonymous that it was a construct of the left
- e. Stand back and watch Anonymous destroy the left themselves

MIKE STACK – (Making productive use of Weingate)

- a. Keep Mike focused and his PD up to date on Neal Rauhauser
- b. Hillsborough NJ Municipal Court Harassment Complaint against Neal Rauhauser completed
- c. Judge deemed valid process service was made to Mark Rasch, the attorney of record in Project Vigilant
- d. Bench Warrant issued for Neal Rauhauser early February for not appearing on scheduled court date that appeared on the summons served

- a. Crooks and Liars.com is the only website advertised on this smear site (evidence & particulars have been documented already)
- b. Neal Rauhauser is one of the only ones who have posted there
- c. John Amato is the owner of crooksandliars.com (we have all the players involved, including Karol Kuns (@karoli) and Diane Sweet)
- d. Anonymous has been advised that this site also obtained two internet names attached to the crooksandliars domain, that being...

occupyamericapac.org – Created 10/6/2011

occupyamericapac.com – Created 10/5/2011

We believe these are the hidden, dormant accounts waiting to take over once Anonymous is fully co-opted

NADIA NAFFE

- a. We've read the Twitter timeline
- b. You stated that the relationship between O'Keefe & Naffe has only been 2 years
- c. Contradicts the story that she has 6-7 years worth of emails by O'Keefe
- d. There's a concern that O'Keefe has been hacked. If so, please have him contact me any time tonight or tomorrow
- e. We have a lawyer in his area who knows him and that's Jordan B. Rickards, Esq., Milltown, N.J.
- f. If Naffe falls into Rauhauser's hands, that's exactly what you want. We'll make fools of them if she plays into that hornet's nest, no worries.

I honestly feel we've got this. The key here is to stay calm, let them ramble incoherently while

we focus on goals (yours & ours). In order to accomplish this, we just break it down into manageable pieces, delegate people to focus on their areas and everything will get done from the police being informed — to Anonymous projecting against the left — to you becoming the sorely needed leadership voice the Tea Party has needed since Sarah Palin fell off the face of the earth and Glen Beck went insane.

Remember, the left is losing their grip and the goal is to capitalize on that and strengthen ours. We'll get there. It's working and we'll help you. Just do me a favor and keep Mandy out of this one. She's too emotionally attached, can't detach and becomes an obstacle we should have gone to you about a long time ago.

This email is to accomplish 3 areas; a) Keep the Boston PD apprised of additional information and get you in that loop; b) Inform you of who is behind www.indictbreitbart.org together with the connected websites to it (aliases); and c) Give O'Keefe some additional information he may or may not have.

Below you will find references that map out Internet discussions regarding the O’Keefe/Naffe case. While those references would be best-suited for O’Keefe’s benefit and we urge you to forward them to him, we wanted to point out one technicality of interest that you may want to keep in the back of your mind.

The article we focused in on was entitled “Pimp of the Year: James O’Keefe...” dated December 23, 2011, hosted on the www.occupyforaccountability.org website.

A DNS check for this website shows that 14 websites share the same Internet address 208.109.95.2 hosted by secureserver.net.

Interestingly enough, www.indictbreitbart.org alongside velvetrevolution.us are among them. 13 names are registered through GoDaddy, Inc. and marked “Registration: PRIVATE”. But the parent owner is registered to a name, Velvet Revolution, whom as we both know, is Brett Kimberlin and Neal knows we know it because we’ve posted it around the Internet already to make others aware of Velvet Revolution’s aliases. How he did that is explained here:

Being that www.occupyforaccountability.org includes a sidebar advertisement for <http://anonops.blogspot.com/> which promotes the “FuckFBIFriday” activities, among other pro-Anon attacks, let me see what I can do to get Boston PD up to date on these connections, including but not limited to a convicted felon that has you in his cross-hairs. Boston PD is already investigating Rauhauser. We gave them his name last November. I just want to follow that up with letting them know who is behind some of the websites that promote “FuckFBIFriday” and want political journalists “indicted”.
